Pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 and Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Members of the Company holding shares either in physical or dematerialized form as on the cut-off date i.e. Friday, 16<sup>th</sup> September, 2016 are offered the facility of exercising their votes by electronic means through the remote e-voting services provided by M/s. Karvy Computershare Private Limited ("Karvy") on any or all businesses to be transacted at the Annual General Meeting as specified in the notice.

The remote e-voting shall commence on Tuesday, 20<sup>th</sup> September, 2016 (09:00 a.m.) and shall end on Thursday, 22<sup>nd</sup> September, 2016 (05:00 p.m.). The remote e-voting will be disabled by Karvy after the said date and time. Once the votes are casted by the Members on the various resolutions by remote e-voting, he/she will not be allowed to change it subsequently. Furthermore, a member may participate in the Annual General Meeting even after exercising his/ her vote through remote e-voting but shall not be allowed to cast their vote again at the Annual General Meeting.
