### **A. Introduction and Background**

### **B. Objectives of the Policy**

The Board of Directors shall monitor the implementation of the CSR Policy and CSR annual action Plan-

1. The Board of Directors shall Identify CSR Projects, CSR expenditure and implementation schedule from time to time as may be required.
2. Total expenditure for the CSR activities shall be approved by the Board.
3. Any surplus arising out of the CSR Projects shall not form a part of the business profit of the Company.
4. The Company may build CSR capacities of their own personnel or personnel of its Trust or Society, as well as those of the Agencies through institutions with established track records of at least three Financial Years but such expenditure (including expenditure on administrative overheads) shall not exceed 5% of the Approved Budget of the Company in one Financial Year.
